## HEAD START PROCEDURES FOR: Releasing Children to an Authorized Adult COMPONENT: CENTER FOR YOUNG LEARNERS

### 1.0 Scope: <u>Head Start Performance Standard 1302.47(b)(5)(iv) Children will</u> only be released to an authorized adult.

#### 4.0 **Procedures:**

- 4.1 Children will be signed in by parents or caregivers when arriving at school each morning. Sign in sheets are located in each classroom. During times of pandemic, sheets may be located in other designated areas to minimize exposure in classrooms. Staff will note if a child has bruising, abrasions or a discharge.
- 4.2 At pick up time, children must be signed out by a parent or adult listed on the Emergency Card.
  - 4.3 Those who pick up a child must show a driver's license or other photo ID as identification until the teacher recognizes them.
- 4.4 No child will be released to anyone who appears to be under the influence of drugs or alcohol. Necessary authorities will be contacted to ensure the safety of the child.
- 4.5 School age and Head Start children are not allowed in the EHS classroom at any time. Parents are encouraged to pick up infants first.
