- 4.1. Under no circumstances shall a Head Start program solicit, encourage, or in any way condition a child's enrollment or participation in the program upon the payment of a fee.
- 4.2. Region 14 ESC Head Start will provide services to Callahan, Comanche, Eastland, Fisher, Jones, Haskell, Mitchell, Nolan, Shackelford, Stephens and Taylor Counties. Anson, Albany, Breckenridge, Clyde, Cisco, Colorado City, Comanche, DeLeon, Eastland, Hamlin, Stamford, Sweetwater, and Merkel Head Starts are center-based. Region 15 EHS/ Head Start delegate will provide services to Brown, Coleman, McCulloch and Runnels Counties. Ballinger, Brady, Brownwood, Coleman, and Winters are center-based.
- 4.3. Early Head Start is provided in Sweetwater, Nolan County; Brownwood, Brown County; Comanche, Comanche County; Colorado City, Mitchell County, De Leon, Comanche County, Hamlin, Jones County.
- 4.4. Grantee/Delegate in each of these centers and home-based programs will NOT accept payment from parents for any services for their children.
- 4.5. Grantee/Delegate will not solicit, encourage, or make payment or fees a condition of a child's enrollment. Examples: classroom supplies, field trips, gift exchanges, diapers, wipes, formula, or clothes, etc.
- 4.6. All donations will be recorded on the In-kind Contribution form.
