4.0 **Procedures:**

- 4.1 In a timely and effective manner, ISD Staff will collaborate with parents as partners in the health and well-being of their children in a linguistically and culturally appropriate manner.
 - 4.1.1 Linguistically appropriate consent forms that include consent for health and developmental procedures will be completed at the time of application to Head Start and updated annually.
 - 4.1.2 Obtain or conduct health screenings. During times of emergencies, natural disasters, pandemics, etcetera, Head Start will abide by CDC guidelines, Office of Head Start directives, state pandemic guidelines and local ISD emergency preparedness/pandemic plans.
 - 4.1.3 Results of screenings will be given to parents through conferences, phone calls, and parent letters.
 - 4.1.4 Results of screenings will be documented in the web-based data system.
 - 4.1.5 Follow up and referrals will be initiated and completed with collaboration between parents and staff.
 - 4.1.6 Written documentation of parent refusal of services will be completed

- 4.1.7 Health emergencies that require rapid response on the part of staff or immediate medical attention information will be shared with parents through ISD Parent Handbook and Head Start Parent Handbook.
- 4.1.8 Parents will complete the Emergency Contact Card at registration with child's information, parent's contact information, alternate contacts in case parents cannot be reached, primary physician, dentist and allergies or medical conditions. The Emergency Card will also contain the signature of the parent for advanced authorization for emergency care. The emergency card information will be updated as changes occur.
