Procedures:

- 4.1 ISD Staff will gather information from parents related to health, dental or development.
- 4.2 FSW will work with parents to facilitate appointments, travel, and payment as needed by each parent to complete further diagnostic testing, evaluation, treatment and follow-up plan.
- 4.3 ISD Staff and Health Consultants will monitor health histories, exams and screenings to identify any new or recurring developmental, medical, oral, or mental health concerns.
- 4.4 ISD Staff or Health Consultant will communicate with parents of children with identified needs through phone calls, home visits, and conferences.
- 4.5 Communication and follow up action will be documented in the case notes.
- 4.6 ESC and ISD Staff will encourage and assist parents to assume responsibility for obtaining all health services, providing assistance in accessing resources, and in removing any barriers to services that the

parents encounter.

- 4.7 FSW will monitor families' progress of accessing medical/dental care and equipment and document in the case notes and/or service notes.
- Program will facilitate and monitor necessary oral health preventive care 4.8 according to the Texas Health Steps Periodicity Schedule. Topical fluoride

treatments will be provided by a dental provider. Program will provide toothpaste for dental hygiene for children.

During times of emergencies, natural disasters, pandemics, etcetera, 4.9 Head Start will abide by CDC guidelines, Office of Head Start directives, state pandemic guidelines and local ISD emergency preparedness/pandemic plans.
