# HEAD START USE OF HEAD START FUNDS FOR MEDICAL EXPENSES COMPONENT: CENTER FOR YOUNG LEARNERS

cf1.0 Scope: Performance Standard 1302.42(e)(1),(2) This procedure describes by which Early Head Start and Head Start funds are used for professional medical and dental services when no other source of funding is available.

### 4.0 **Procedures:**

- 4.1 When a child is determined to have no means of payment for professional health services or dental expenses, the Family Service Worker is to notify the ESC Health/Safety/Nutrition Consultant of need.
- 4.2 The Community Resource Directory will be utilized by the Family Service Worker to assist the family in securing a healthcare provider.
- 4.3 The FSW, with prior approval from the Health/Safety/Nutrition Consultant, will supply the family or provider with a "Letter of Payment" prior to the appointment.
- 4.4 Parents will take the "Letter of Payment" to the provider at the time of the appointment.
- 4.5 The Family Service Worker and ESC Health/Safety/Nutrition Consultant will document in case notes the lack of other available funding and document follow-up on efforts to access other available funding.
- 4.6 Bill for services will be sent through the ESC process for payment.
- 4.7 Program funds will provide diapers and formula for enrolled children during the program day.
