 - 4.1.2 Family Service Workers will complete a credential or certification in social work, human services, family services, counseling or a related field. Family Services Workers will receive training on the Family Service Credentialing.
 - 4.1.3 Family Service Workers must provide the grantee with a copy of the certificate they receive.
 - 4.14 Family Service Workers will receive training and side by side coaching from a consultant in a related field (e.g., social work, mental health) or equivalent coursework.
